## SECOND NOTICE OF PUBLIC CALL (CONVOCATION)

The General Director of the Corporation for Sustainable Development of the Archipelago of San Andrés, Providence and Saint Kethlina - CORALINA invites the Raizal Community of the Archipelago Department of San Andres and Providence to register as candidate in the process of popular election of the two (2 ) Raizal Representatives of San Andres and one (1) Raizal Representative of Providence Island, each with their substitute before the Directive Council of the Corporation for the Sustainable Development of the Archipelago of San Andrés, Providence and Saint Kethlina CORALINA for the institutional period of January 1<sup>st</sup>, 2020 to December 31<sup>st</sup>, 2023.

### I. OF THE REQUIREMENTS TO BE CHOSEN AND HOW TO ACCREDIT THEM:

The members of the Raizal Ethnic People traditionally settled in the territory of jurisdiction of CORALINA, who aspire to be elected as representatives and substitutes of their community before the Directing Council, must comply with the conditions described below and must approach the Corporation, previously with a Minimum of Ten (10) calendar days to the date established for the election, the following documents:

1. Be over 18 years old (photocopy of Citizenship Card)
2. Be of the Raizal Ethnic People (Photocopy of the OCCRE Card indicating their Raizal status, or certificate issued by the OCCRE that belongs to the Raizal ethnic group, according to their ancestral origin, documents necessary to prove their status as part of the Raizal Ethnic People).
3. Not having been sanctioned for environmental violations in the Archipelago. (Certification issued by the Legal Department of CORALINA).
4. Sworn statement of the candidate that he/she has permanent residence in the Archipelago, at least for the last five (05) years.
5. The applicant candidate must comply with the provisions of article 45 of Law 47 of 1993 reads as follows: "Public employees who exercise their functions within the territory of the archipelago department and have a direct relationship with the public, must speak the Spanish language and English "(bold out of text). A condition that will be accredited by means of a certificate issued by the Ethnic-linguistic norm from the Secretariat of Education of the Department or whoever acts as such.
6. To be a bachelor. Situation that is credited with a copy of the Bachelor's degree.
7. To prove knowledge or experience in environmental matters. Situation that is accredited with the Diplomas or certificates of studies in environmental issues and / or labor certificates or its equivalent.
8. Not being involved in a cause of disability or incompatibility.
9. Not have a criminal, disciplinary and / or fiscal record.
10. Submit a proposal indicating the reasons why he/she wishes to postulate his/her name to the Directive Council of CORALINA. This proposal must include a written statement that expresses the will to participate in the democratic process of popular election as representatives of the Raizal Ethnic People before CORALINA Directive Council.
11. Two (02) photographs size 2 x 2.5 cm., In black and white, matte paper completely white background.

**PARAGRAPH:** Those interested in participating in the elections must submit the supporting documents that accredit the requirements established in this article.

### III. INSCRIPTION OF CANDIDATURES:

Raizals who aspire to be representative of their community before CORALINA Directive Council must register their list (Principal and substitute) for San Andres and Providence before the Corporation for the Sustainable Development of the Archipelago of San Andres, Providence and Saint Kethlina - CORALINA on the date and time indicated for this purpose in the Call.

Likewise, the Corporation for Sustainable Development of the Archipelago of San Andrés, Providencia and Santa Catalina –CORALINA will publish a copy of the call in visible and relevant places of the Entity (San Andres and Providence) and on its website, as well as in visible places and pertinent of the Government of the Department Archipelago and the Mayor's Office of Providence and Saint Kethlina. Likewise, they may send a copy of the call to be published in the churches of the Archipelago and other organizations that request it.

### III. III. PLACE OF INSCRIPTION OF THE CANDIDATURE:

- a) **Registration of the Candidacy in the Island of San Andres:** General Secretary of CORALINA, located on the Via San Luis, Kilometer 26, first floor.
- b) **Registration of the Candidacy in Providencia Island:** CORALINA Office, located in Mountain.

### IV. OF THE VOTING JURIES.

The four (4) voting stations selected to carry out the election of the representative of the Raizal Ethnic People of San Andres before CORALINA Directive Council, on the Island of San Andres and on the Island of Providence, will be those determined by the Corporation in coordination with the National Registry of the Civil Service. In each station 3 tables will be installed, each of which will have six (6) juries.

The voting juries will be chosen by random draw from the list of public officials of the Department for each of the Islands according to the place of residence of the juries, which will be in charge of by the National Registry of the Civil Service.

The designation of the juries will be done through an administrative act signed by the Governor of the Department.

Both the draw for the selection of the juries and the preparation of the administrative act will be carried out with the support of the secretary of the Directive Council.

The list of voting juries will be published with due anticipation on the CORALINA website, at the offices of CORALINA headquarters in San Andres Island and at CORALINA office on Providence Island, at the Departmental Government and at the Mayor's office.

The designation will be of forced acceptance.

Notwithstanding the foregoing, the Agreement No. 004 of August 02, 2019 is an integral part of this Notice of Convocation "By which the procedure for the election of the principal and substitute representatives of the Raizal Ethnic Community is regulated before the Directive Council of the Corporation for the Sustainable Development of the Archipelago of San Andres, Providence and Saint Kethlina - CORALINA, and other provisions are adopted".

#### **V. OF THE PUBLICITY AND / OR MASS MEDIA OF PUBLICATION:**

The call will be published in one (1) opportunity in a newspaper of wide regional circulation. It must be published for a period of five (5) calendar days before the date established to develop the popular election, in order to guarantee the principle of publicity it will be disseminated by mass media (radio, television, digital, website of the Corporation) or any other means of communication of regional coverage. The call must be made in English and Spanish.
