"By means of the which is concentrated the election of the representatives of the raizal ethnic people before de Board of Directors of the Office of Circulation and Residence Control –OCCRE and the Directive Board of the Corporation for the Sustainable Development of Archipelago of San Andres, Providence and Santa Catalina - CORALINA "

**THE GOVERNOR OF THE DEPARTMENT ARCHIPIELAGO DE SAN ANDRES, PROVIDENCE AND SANTA CATALINA**, in the exercise of its Constitutional and Legal powers, especially those contained in article 113 and numerals 1 and 2 of article 305 of the Constitution, article 6 of Law 489 of 1998, article 3 of Law 1437 of 2011, and

**CONSIDERING**

That according to article 37 of Law 99 of 1993 in accordance with article 24 of Law 47 of 1993, the Board of Directors of the Corporation for Sustainable Development of the Archipelago of San Andrés, Providence and Santa Catalina - hereinafter CORALINA, It includes, among others, two (02) representatives of the native community of San Andres Island and one (01) representative of the native community of Providence Island, elected by popular election.

That the Board of Directors of CORALINA, through Agreement number 004 of 2019, regulated the procedure for electing the principal and alternate representatives of the Raizal Ethnic People before the pluri-mentioned Board, for the period 2020-2023.

That according to numeral f) of article 25 of Decree 2762 of 1991 the Board of Directors of the Office of Circulation and Residence Control - hereinafter the OCCRE, is integrated, among others by, two (02) representatives of the native community of San Andrés and one (01) representative of the native community of Providence, elected by vote, within the respective community.

That the Board of Directors of the OCCRE through Agreement 019 of May 24<sup>th</sup>, 2019 modified the Agreement 01 of March 28<sup>th</sup> of the same year, the latter, with which said collective adopted its internal regulations and specified the procedure for the election of its native representatives ob. clt., for the period 2020-2023.

That in consideration of the foregoing, through Agreements numbers 024 of November 15<sup>th</sup>, 2019 and 025 of December 13<sup>th</sup> of the same year, the OCCRE -, called on the Raizal Ethnic People to elect their representatives, due to the end of the period of the current members. CORALINA did the same through notices dated December 30, 2019 and January 20, 2020.

That both election processes have the technical support of the National Registry of Civil Status.

That by virtue of the principle of harmonic collaboration provided in article 113 of the Constitution, the principle of coordination provided in article 6 of Law 489 of 1998 and the principles of participation, responsibility, efficiency, economy and celerity, established in article 3 of Law 1437 of 2011 and / or Code of Administrative Procedure and of the Contentious Administrative Proceedings; it is considered better to concentrate both elections, for the same date, time, zones and / or voting stations, with the aim of optimizing the use of time, the human resource available for one or another day, as well as the economic resources originated by both entities, among others; Therefore, we guarantee the effective realization of the electoral process with the least possible wear.

That, in merit of the above,

### RESOLVES

**ARTICLE ONE:** Concentrate for the same date, time, zones and / or voting stations, the election of the representatives of the community of the Raizal Ethnic People before the Board of Directors of the Office of Circulation and Residency Control - OCCRE and the Directive Board of the Corporation for the Sustainable Development of the Archipelago of San Andrés, Providence and Santa Catalina - CORALINA, for the reasons given in the motivational part of this administrative act.

**ARTICLE TWO:** Mark the day **Monday Sixteen (16<sup>th</sup>) of March of the year 2020, from 8.00 a.m. at 4.00 p.m.**, as the date and time to carry out the election of representatives of the community of the Raizal Ethnic People before the Board of Directors of the Office of Circulation and Residence Control - OCCRE and the Board of Directors of the Corporation for Sustainable Development of the Archipelago of San Andrés, Providence and Santa Catalina - CORALINA.

**ARTICLE THREE:** The areas and / or voting stations for the Island of San Andrés and for the Island of Providence will be determined in a joint meeting between the OCCRE and CORALINA, under the technical support of the National Registry of Civil Status.

**ARTICLE FOUR:** By Secretariat, communicate to the Administrative Director of the Office of Circulation and Residence Control - OCCRE; to the Administrative Director of the Corporation for the Sustainable Development of the Archipelago of San Andrés, Providence and Santa Catalina -CORALINA, and to the National Registry of Civil Status - Delegates for the Islands of San Andrés and Providence, as well as to the Mayor of the Municipality of Providence and Santa Catalina.

**ARTICLE FIVE:** By secretariat, make rigorous publications in **Spanish, English and Creole**.
